<b>Type of data processed</b>	<p>The personal data collected may include, but is not limited to:</p> <ul style="list-style-type: none"> <li>• personal data (name, surname);</li> <li>• contact data (e-mail address, telephone number);</li> <li>• professional data (company, role);</li> <li>• other data provided voluntarily by the data subject.</li> </ul>
<b>Legal basis for processing</b>	<ul style="list-style-type: none"> <li>• exchange of pre-contractual information</li> <li>• Execution of contractual obligations</li> <li>• legal, administrative and accounting obligations</li> </ul>
<b>Purpose of the processing</b>	<p>Personal data is collected and processed for the following purposes:</p> <ul style="list-style-type: none"> <li>• management of contractual relationships with customers and suppliers</li> <li>• <b>finding and managing business contacts;</b></li> <li>• <b>communication of data to authorized distributors</b>, who will use them for their own <b>marketing purposes</b>, such as sending promotional, commercial and informative communications relating to products and services.</li> </ul>
<b>Data Transmitted or Shared</b>	<ul style="list-style-type: none"> <li>• <b>external professionals</b> who are appointed as data processors pursuant to Article 28 GDPR</li> <li>• <b>authorized distributors and business partners</b> who are appointed as data processors pursuant to Article 28 GDPR and will act as independent data controllers for their own marketing purposes. The updated list of distributors can be requested from the Data Controller.</li> </ul>
<b>Data transfer abroad</b>	No. The transfer of data abroad may result from the marketing activity conducted by the distributors duly appointed as data processors for the activity
<b>Data storage</b>	according to legal obligations
<b>Automated process</b>	No
<b>Data collected from the data subject and cookies</b>	<ul style="list-style-type: none"> <li>• The data are collected from the data subject using manual and/or IT tools, in compliance with the principles of lawfulness, fairness, transparency and data minimisation, adopting appropriate security measures.</li> <li>• The <a href="http://www.montolit.com">www.montolit.com</a> website uses only technical cookies. <b>Rights of the data subject</b>	<ul style="list-style-type: none"> <li>• Access to data</li> <li>• Rectification of data</li> <li>• deletion of data (if this does not conflict with other mandatory regulations, e.g. tax regulations)</li> <li>• restriction of processing (if this does not conflict with other mandatory regulations)</li> <li>• objection to processing (if justified)</li> <li>• lodge a complaint with a supervisory authority</li> </ul>
<b>mandatory provision of data</b>	The provision of data is optional, but failure to provide it will make it impossible to access the services and to transmit the data to distributors for the marketing purposes indicated above.
